Commissioner Sharp commented on an upcoming Personal Committee Meeting and acquiring specific road signs.

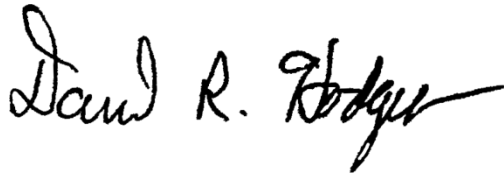
