AMENDMENT TO IONIA COUNTY MEDICAL EXAMINER SERVICES AGREEMENT

THIS AMENDMENT is made effective the 30th day of September 2017, by and between Edward W. Sparrow Hospital Association, a Michigan nonprofit corporation ("Contractor"), and County of Ionia, a municipal corporation and political subdivision of the State of Michigan ("County").

WHEREAS, Contractor and County entered into a Medical Examiner Services Agreement effective February 1, 2014 (the "Agreement"); and

WHEREAS, pursuant to Section 20 of the Agreement, Contractor sent written notice to the County by letter dated June 1, 2017 that Contractor will terminate the Agreement effective September 30, 2017; and

WHEREAS, Contractor and County have agreed to forgo the termination of the Agreement and amend the Agreement as described herein.

NOW, THEREFORE, the parties agree as follows:

- 1. Section 20 shall be restated in its entirety as follows:
 - 20. Agreement and Termination. This Agreement shall become effective and performance thereon shall commence on the 1st day of February 2014 and shall continue through the 31st of December 2017. Notwithstanding any other provision in this Agreement to the contrary, either party upon one hundred twenty (120) days prior written notice to the other party may terminate this Agreement.
- 2. Section 5. A. shall be restated in its entirety as follows:
 - **5. Compensation. A.** The County shall pay the Contractor for Medical Examiner services beginning as of February 1, 2014 as follows:
 - i. An annual rate of Eighty-Five Thousand Two Hundred Sixty-Eight and 00/100 Dollars (\$85,268.00), shall be payable in equal monthly installments of Seven Thousand One Hundred Five and 67/100 Dollars (\$7,105.67) beginning February 1, 2014 through January 31, 2017; and
 - ii. Eighty-Two Thousand Two Hundred Thirty-Five and 47/100 Dollars (\$82,235.47), payable in equal monthly installments of Seven Thousand One Hundred Five and 67/100 Dollars (\$7,105.67) beginning February 1, 2017 through September 30, 2017, and Eight Thousand Four Hundred Sixty-Three and 37/100 Dollars (\$8,463.37) beginning October 1, 2017 through December 31, 2017.

- 3. Section 7. C. shall be restated in its entirety as follows:
 - 7. Required Insurance. C. [Intentionally Omitted]
- 4. The parties hereto ratify and reaffirm all the remaining terms of the Agreement as if set forth herein in full.
