DEMOCRATIC



That **Chris Dodd** having received Fifteen votes is nominated candidate by the **Democratic Party** for the office of the **President of the United States**;


That Mike Gravel having received Eleven votes is nominated candidate by the Democratic Party for the office of the President of the United States;
