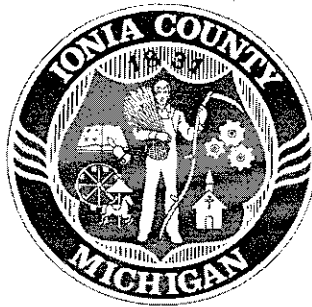

BOSTON TOWNSHIP

ROAD MILLAGE

Shall the limitation on general ad valorem taxes within Boston Township imposed under Article IX, Section 6 of the Michigan Constitution be increased for Boston Township by 1.20 mill (\$1.20 per \$1,000 of taxable value) for a period of ten (10) years, 2015 through 2024, inclusive, to provide funds for the maintenance, improvement, construction and repair of public roads in the Township, and any related financing for these purposes, and shall Boston Township levy such new additional millage for these purposes?

This proposed millage is new additional millage for public road purposes in the amount of 1.20 mill. It is estimated that a levy of 1.20 mill will provide revenue of \$191,838 in the first calendar year. The revenue from this new millage will be disbursed to the Township of Boston and the Ionia County Road Commission.
